If you wish to join NESLC please ring Steve Harris, NESLC Gym Manager on 07790 085104. If you are unsure about whether you are a member:-

You are an NESLC Member if:

Benton Park View (BPV) - you are in HASSRA or RCSL unless you are a HASSRA member in the local office club CMG (Room BP5302 only).

Tyneview Park (TVP) - you are in HASSRA unless you are a member in the local office clubs (Newcastle Pension Centre, NCIB/FES), or an RCSL North member who has opted to retain your NESLC membership.

Durham House (DH) - you are in HASSRA or an RCSL North member who has opted to retain your NESLC membership.

Waterview Park (WVP) - you are an RCSL North Member who has opted to retain your NESLC membership.

If you are a HASSRA member in a local office club at any of the above locations you can choose to join NESLC for an additional £8 per year.

If you are an RCSL North member at TVP, WVP or DH and have not opted to retain your NESLC membership you can join NESLC for an additional £8 per year.

NESLC PROPOSED CONSITUTIONAL CHANGES

Background

When NESLC was formed in 2005, membership was dependent on being a member of the sponsoring organisations Sports Club or by joining NESLC as an Associate member. The sponsoring organisations sports clubs were HASSRA for DWP and RCSL for HMRC.

Over the years there have been changes in the way that HASSRA and RCSL administer membership of their organisations which impacts on an individual's membership of NESLC and which requires amendments to the NESLC constitution to reflect those changes.

In addition there are now more government organisations on the Newcastle Estate in addition to those when NESLC was formed.

The NESLC constitution can only be amended at the NESLC AGM or at a special general meeting and any proposed changes come into force the following year. This means that NESLC are constantly playing catch up to reflect the changing occupancy of the Newcastle Estate and membership structures of HASSRA and RCSL.

The following proposal is to repeal the current version of Rule 4 of the NESLC constitution and replace it with a generic Rule to cover membership.

The NESLC Policy document will then reflect the detail of how the different membership of the sponsoring organisations sports clubs on the Newcastle Estate will be dealt with for membership purposes of NESLC and allow changes to take place in real time.

Proposed Amendment

RULE 4 – MEMBERSHIP

4.1 Full Members

- 4.1.1 An individual member of staff who is eligible to join the sponsoring organisations Sport Club by virtue of working on the Newcastle Estate shall not join NESLC directly and can only become a full member of NESLC by joining the respective organisations sports club.
- 4.1.2 A retired member of staff who worked on the Newcastle Estate at the time of retirement and who continues to remain a member of the sponsoring sports club in retirement retain full membership if they have nominated NESLC as their preferred club in retirement.
- 4.1.3 Membership of NESLC is dependent on the relevant sponsoring organisations sports club paying the appropriate disbursement fee to NESLC.

4.2 <u>Associate Members</u>

- 4.2.1 Associate members shall be able to join NESLC at the Management Committee's discretion.
- 4.2.2 There will be various types of of Associate membership available as set out in the NESLC Policy Document.
- 4.2.3 Associate members of the club shall adhere to the policies of the club as determined by the NESLC Policy document.
- 4.2.4 Associate Membership of NESLC shall continue until such time and on such conditions as set out in the NESLC Policy document.
- 4.2.5 Associate Members shall not be allowed to vote or hold an office position of the club or any section, without the permission of the Management Committee.
- 4.2.6 Associate membership fees will be those payable in accordance with the NESLC Policy document.
- 4.3 <u>Duration of Membership</u>
- 4.3.1 Membership of NESLC shall be deemed to commence, end and where appropriate, be suspended or revoked, as determined by the individual members's actual membership of their supporting organisations sports club.
- 4.3.2 The duration of Associate membership of NESLC shall be determined by the rules of the Management Committee and following payment of all required fees or subscriptions.

Current Constitution

Rule 4 – MEMBERSHIP

- 4.1 Full Membership
- 4.1.1 Individual members of staff who work on the Newcastle Estate and who are a member of HASSRA/RCSL automatically become full members of NESLC where HASSRA/RCSL pay the appropriate disbursement fee to NESLC.

An individual member of staff who is entitled to join HASSRA/RCSL by virtue of working on the Newcastle Estate shall not join NESLC directly and can become a full member of NESLC by joining HASSRA/RCSL.

4.1.2 A retired member of staff who worked on the Newcastle Estate at the time of retirement and who continues to remain a member of HASSRA/RCSL will have all rights of a full member subject to HASSRA/RCSL paying the appropriate disbursement to NESLC. Where NESLC do not receive a disbursement from HASSRA/RCSL, a retired member will need to also join NESLC as a "Type C" associate to retain NESLC membership.

4.1.3 Any individual retaining HASSRA membership by virtue of entitlement to join and becoming a HASSRA National Associate Member, shall also have all the rights of a full member subject to that individual notifying the NESLC Secretary that they wish to be affiliated to NESLC at the time of submitting their HASSRA National Associate Membership application and subject to HASSRA paying the appropriate disbursement to NESLC.

Where NESLC do not receive a disbursement from HASSRA, the HASSRA National Associate Member will need to join NESLC as a "Type C" associate to retain NESLC membership.

4.2 <u>Associate Membership</u>

- 4.2.1 Associate members shall be able to join NESLC at the Management Committee's discretion. Associate membership shall continue until such times and on such conditions as the Management Committee may decide.
- 4.2.2 In addition, both HASSRA and RCSL may permit associate membership consistent with their respective rules and constitutions and these members shall also be associate members of the Newcastle Estate Sports and Leisure.
- 4.2.3 Each section of the club shall not have more than 33% associate membership as a percent age of the total membership of that section.
- 4.2.4 Associate members of the club shall adhere to the policies of the club as determined by the NESLC Management Committee. In addition, they shall not be allowed to vote or hold the office of President, Vice President, Chairman, Secretary, Assistant Secretary, Treasurer, Assistant Treasurer, Captain of Vice Captain of the club or any section, without the permission of the Management Committee.
- 4.2.5 Where an associate member is a HASSRA Cor RCSL member working in a location other than on the Newcastle Estate, he will not count against the 33% quota mentioned in para 4.2.2 above.
- 4.3 <u>Duration of Membership</u>
- 4.3.1 Membership of NESLC shall be deemed to commence, end, and where appropriate, be suspended/revoked, as determined by the individual members actual membership of either HASSRA or RCSL.
- 4.3.2 The duration of Associate membership of the NESLC shall be determined by the rules of the Management Committee and following payment of all required fees of subscriptions.

NESLC Membership Cards

In order to take part in NESLC offers and trips you will be required to have a membership card. The cards are free to members of HASSRA and RCSL at Benton Park View, Tyne View Park and Durham House with some exceptions. See page 1 for advice on NESLC membership.
